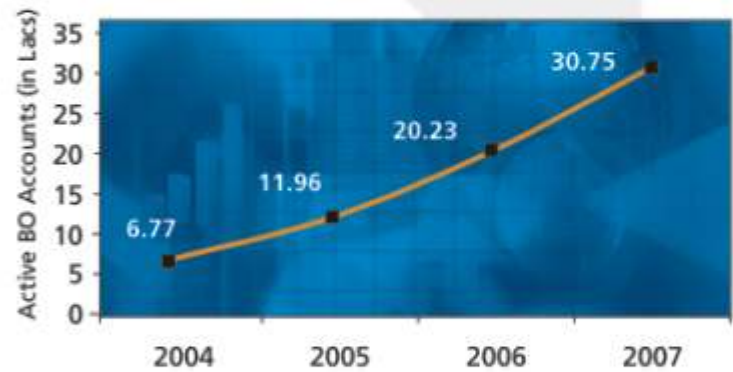

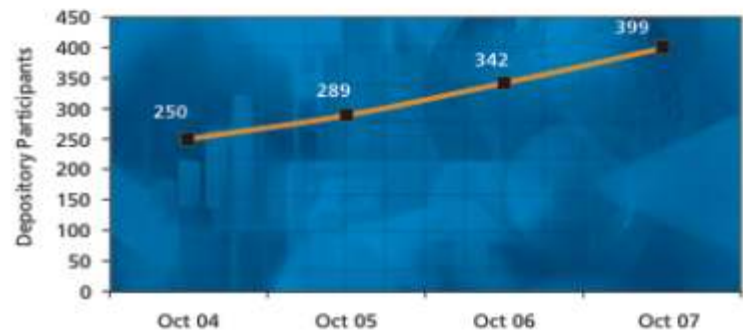
Beneficial Owners

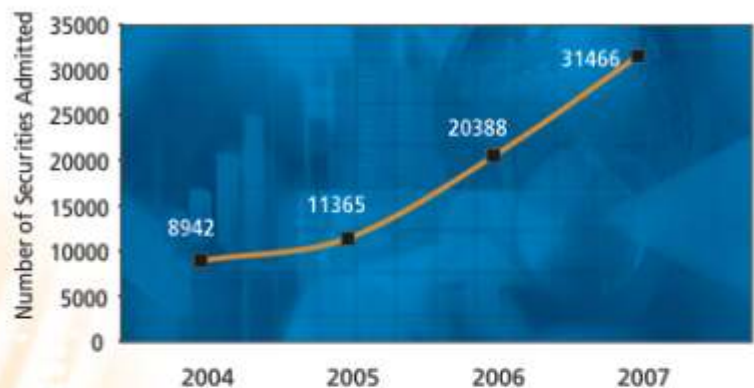
Depository Participants

WHAT'S NEW ?

INFORMATION ON CORPORATE ANNOUNCEMENTS THROUGH EASI

CDSL has introduced a unique, internet-based facility giving information, sourced from BSE, about corporate announcements of companies. Investors registered for CDSL's internet facility easi can now receive 'alerts' and view information about corporate announcements of companies in which they have equity holdings. In addition, they can also select other companies about which they desire to get such alerts and information. This facility enables them to get alerts about events in all companies of interest to them, on a single page instead of having to track the same from multiple sources, including multiple websites.

This new facility of corporate announcement information is available to all users of CDSL's immensely popular internet facility 'easi', which already gives registered users, information about the holdings and transactions in their CDSL demat accounts along with a valuation of their portfolio. CDSL levies no charge for easi, and any CDSL demat accountholder can register for easi through CDSL's website, www.cdslindia.com. Investors should contact their DPs for further information.

SUPERVISION OF BRANCHES OF DEPOSITORY PARTICIPANTS (DPs)

Currently Depository Participants (DPs) operate through branches directly connected with CDSL and some are connected through the back office software of the DP. Certain DPs are connected with CDSL through one or more DP terminals. While, some of the DPs have offline branches that function either as full-fledged branches or only as a collection center.

With a view to ensure better risk control, SEBI vide its circular MIRSD/DPS-III/ Cir - 9 /07 dated July 3, 2007 has directed all DPs to implement adequate mechanisms for the purpose of reviewing, monitoring and evaluating its internal accounting controls and systems. DPs will have to put in place appropriate mechanisms to ensure that their branches are carrying on the operations in compliance with the applicable regulations, bye-laws, etc. Further, DPs are also required to put in place suitable internal control systems to ensure that all branches are exercising due diligence in opening accounts, complying with KYC requirements, in ensuring systems safety, in complying with client instructions, manner of uploading client instructions, in verifying signatures and in maintaining client records, etc. DPs shall also ensure that the branches are suitably integrated.

DPs should take note of the same and accordingly implement the changes in their internal operating requirements immediately.

DISCONTINUATION OF USING MAPIN CARD AS PROOF OF IDENTITY

SEBI vide its circular no. MRD/DoP/Dep/Cir-12/2007 dated September 7, 2007 has discontinued acceptance of MAPIN as an Identity proof for the purpose of opening a demat account. Investors are requested to kindly take note of the same. The details of the circular are also available on SEBI's website www.sebi.gov.in.

dated 24th August 2004, had issued certain guidelines for documents to be submitted as address proof. One such document prescribed for submission of address proof is a copy of the bank passbook or statement duly attested by the bank manager.

CDSL has received representations from investors and DPs that certain banks levy a fee for attestation of the bank statement and this makes it difficult for an investor to open an account. With a view to obviate the problems faced by investors, the requirement of attestation has been withdrawn and investors can now submit the original bank statement along with a cancelled cheque for the proof of address. Investors should also note that the statement should not be more than 6 months old.

INVESTOR AWARENESS PROGRAMS CONDUCTED BY CDSL DURING SEPTEMBER- OCTOBER 2007

With a view to educate investors about their rights and responsibilities, CDSL has held Investor Awareness Program (IAPs) across the country. Each IAP consists of a 90-minute presentation followed by a question-answer session. CDSL officials explain the concepts pertaining to demat, IPO, online trading, settlements, etc. and also

provide booklets on demat, which contain a wealth of information.

CDSL in association with Eenadu, a leading Telugu daily, held an IAP at K.L.N. Prasad Auditorium, Red Hills, Hyderabad on October 23, 2007. Over 450 investors attended this IAP.

Also, CDSL in association with Sakaal, a leading Marathi daily, held an IAP at Sant Ekanath Rangamandir, Osmanpura, Aurangabad on October 27, 2007. The IAP received overwhelming response and over 1200 investors attended the same.

Besides the above IAPs, on 14th October 2007 Doordarshan's Sahyadri channel had a live telecast in which a CDSL official explained in detail various topics like responsibilities / protection to investors, dematerialization of shares, concepts of IPO etc.

DP MEET

CDSL held a meeting of its DPs at Chennai & Kochi on October 18, 2007 & October 19, 2007 respectively. The meetings were very interactive and CDSL officials clarified the queries of the DPs. Further, DP officials also provided suggestions for improvements. CDSL will shortly be holding a meeting of its DPs at New Delhi on November 2, 2007.

KNOWLEDGE CENTRE - SMART FACILITY

With a view to enable CDSL demat account holders to monitor transactions in their accounts, CDSL has launched **SMART (SMS Alerts Related to Transactions)** with effect from October 1, 2007. This facility is available to all CDSL demat account holders.

1. What is SMART?

SMART stands for **SMS Alerts Related to Transactions** in which investors registered for SMART will **receive alerts for all types of debits, subject to a maximum of four ISINs, and for credits into the account due to IPO allotments and corporate actions.**

2. How do I avail of this facility for my demat account?

You will have to approach your Depository Participant (DP) and submit the SMART registration form duly completed. This form can also be downloaded from CDSL's website www.cdslindia.com

3. When will I receive a SMART alert?

You will receive SMART alerts for any debits in the account, subject to maximum of four ISINs, and for credits due to IPO allotments and corporate actions.

4. Is this facility available for all types of demat accounts?

SMART is currently not available for Clearing Member accounts, Client Beneficiary accounts or Client Margin Accounts.

5. What is the registration procedure?

- An account holder will have to submit the SMART registration form duly completed to their DP. The form can be obtained from your DP or downloaded from CDSL's website www.cdslindia.com.
- On verification of all the signatures and details mentioned on the form by the DP, the details are entered in the CDSL system for initiation of this service.
- CDSL will generate an acknowledgment letter, which the DP will certify and hand over or mail to the BO.
- Subsequently, the BO will receive a confirmation message on their cell phone confirming their registration for this facility.

6. What are the charges applicable to BO?

Currently, no charges are levied to subscribe for this facility.
