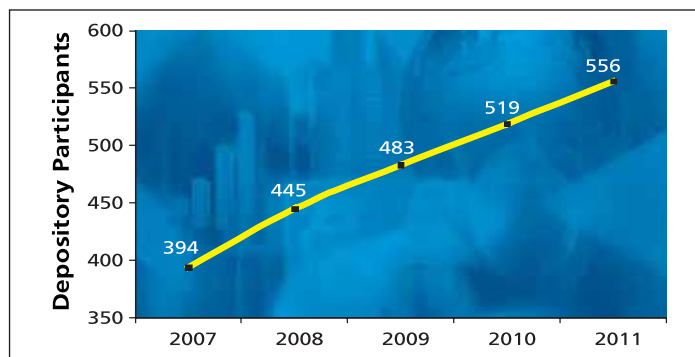
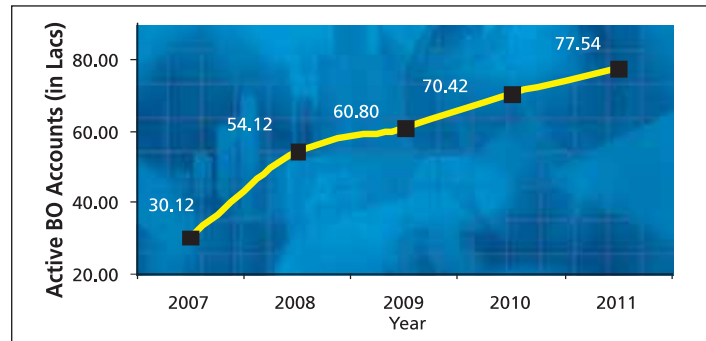

During the last 12 months, the number of active BO accounts with CDSL has increased from 70.42 lakh as on October 15, 2010 to 77.54 lakh as on October 15, 2011, which indicates growth of 10.11%

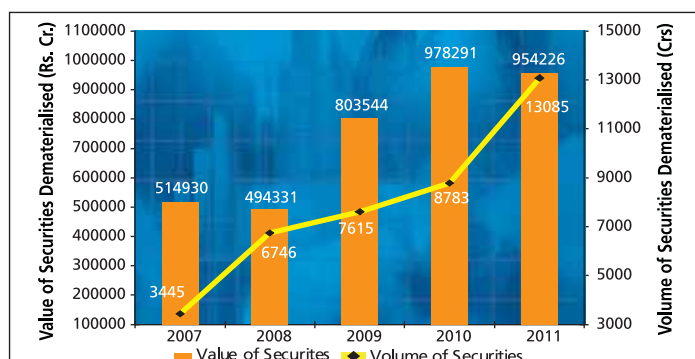
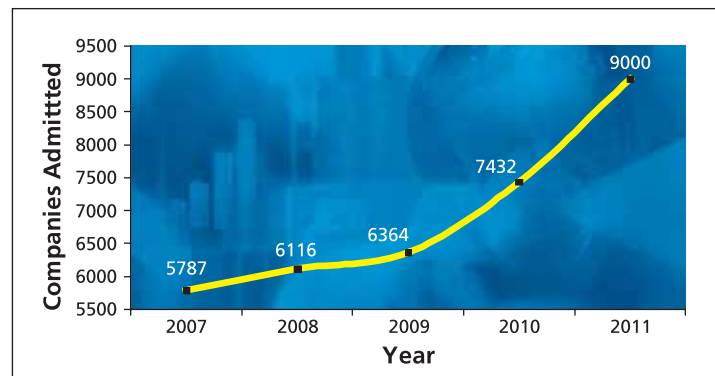


Depository Participants

As on October 15, 2011, CDSL has 556 DPs offering DP services from over 11000 locations across the country. These DPs comprise of CMs, Banks, NBFCs, Custodians, Clearing Houses/ Corporations and Regional Stock Exchanges.

Companies Admitted

The securities of almost all listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As on October 15, 2011, the securities of 9000 companies have been admitted for demat with CDSL.



Securities Dematerialised

During the last 12 months, the volume of securities under custody has increased by 48.98% and the value of securities has decreased by 2.46% respectively.

WHAT'S NEW ?

UNIFORM KNOW YOUR CLIENT (KYC) REQUIREMENTS FOR THE SECURITIES MARKET

Presently, all capital market intermediaries such as Mutual Funds, Portfolio Managers, Collective Investment Schemes, Venture Capital Funds etc. use different forms and supporting documents for Customer Due Diligence (CDD) or Know Your Client (KYC). SEBI, in consultation with major stock exchanges, depositories, AMFI and market participants has simplified the account opening process for individuals opening a broking and/or demat account with a stock broker, who is also a Depository Participant (DP).

With a view to bring about uniformity in the forms and documents, SEBI has directed that w.e.f. January 1, 2012, the same KYC form and supporting documents shall also be used for new clients by all SEBI registered intermediaries. The KYC form will contain basic information of the investor obtained at the time of account opening while dealing with any of the market intermediaries. Further, additional details specific to the area of activity of the intermediary, not covered in KYC should be obtained separately.

For further details, DPs / Brokers / other market participants may refer to SEBI circular no. MIRSD/SE/Cir-21/2011 dated October 5, 2011.

CONVERSION OF PROMOTER HOLDING IN DEMAT FORM

SEBI, vide its circular SEBI/Cir/ISD/3/2011 dated June 17, 2011 had earlier directed all listed companies to convert their entire promoter holdings into demat form before September 30, 2011. SEBI has now extended the current deadline to December 31, 2011. Companies desiring to convert the physical shares of their promoters into demat form may contact any DP of CDSL or may contact CDSL officials on 022-22728153 / 8453.

AUTO DO FACILITY FOR NSE

The National Securities Clearing Corporation Limited [NSCCL], via its Circular no. NSE/CMPT/19068 dated October 05, 2011, has informed that it will upload the Auto Delivery Obligations [Auto DO] of those NSE Clearing Members (CMs) who have requested NSCCL for the generation of their Auto DO through their CDSL Clearing Member account (CM Pool Account). This facility has been made effective from October 10, 2011. **This will help the NSE CMs obtain shortage positions in the DP89 report.**

CMs of NSE wishing to avail the Auto DO facility for their CDSL CM Pool accounts will be required to send a letter

to NSCCL as per the format specified, which is a part of the aforesaid circular. For further details, kindly refer to CDSL communiqué **CDSL/OPS/DP/SETTL/2672**.

EXTENSION OF DEADLINE FOR INTER-DEPOSITORY TRANSFERS

CDSL is pleased to announce that, with effect from **Monday, September 26, 2011**, the deadline for current dated Inter-Depository transactions for DPs has been extended upto 2000 hours (08.00 pm) from present deadline of 1900 hours (07.00 pm) on Monday to Friday. The present deadline of 1430 hours (02.30 pm) remains unchanged for current dated inter-depository transactions on Saturday.

Further, DPs may note that future-dated Inter-Depository transactions may continue to be entered up to EOD (End of Day).

DESTATMENTISATION / RESTATEMENTISATION OF MUTUAL FUND UNITS

Currently, DPs setup online as well as upload transactions related to Destatementisation of mutual funds using 'Destat' or Demat option in 'Demat DP Module' in the CDSL system. Likewise, transactions related to Restatementisation of mutual funds are setup or uploaded using 'Restat' or Remat option in 'Rematerialisation Module'.

DPs should take note that w.e.f. October 01, 2011, setup and upload of transactions pertaining to destatementisation of mutual funds will be allowed only through the 'Destat' option in the 'Demat DP Module'. Also, transactions pertaining to restatementisation / redemption of mutual funds can be setup or uploaded only through Restat option in 'Rematerialisation Module'. For further clarifications, kindly refer to CDSL communiqué CDSL/OPS/DP/REPRT/2654.

WAIVER OF CHARGES IN RESPECT OF OPEN-ENDED MUTUAL FUND SCHEMES

CDSL had earlier informed its DPs that transactions pertaining to open-ended mutual fund schemes would not be charged till September 30, 2011. CDSL is pleased to announce that this waiver has been further extended to March 31, 2012.

BACK DATED HOLDINGS IN DPC9 REPORT

CDSL is pleased to announce that w.e.f. October 1, 2011, the DPC9 report for a back dated period will reflect the transactions pertaining to that period, along with holdings as on the ending date mentioned of that period. The portfolio valuation would be based on the closing rate of the end date mentioned in the period.

SEBI'S CENTRALIZED WEB-BASED COMPLAINTS REDRESS SYSTEM, 'SCORES'

SEBI vide its circular no. CIR/MIRSD/20/2011 dated September 12, 2011 has commenced processing of investor grievances in a centralised web-based Complaints Redress System, 'SCORES'. Some of the salient features of SCORES are as follows:

- Centralised database of all complaints;
- Online movement of complaints to the concerned entities;
- Online upload of Action Taken Reports (ATRs) by the concerned entities;
- Online tracking of status of complaints by investors.

SEBI will take up the investor complaints through SCORES directly with concerned depositories, who in turn, will take up the matter with the concerned DP.

DPs should ensure that adequate steps for redressal of grievances are taken within one month from the date of receipt of the complaint and keep the investor/Depositories duly informed of the action taken thereon.

COMPUTATION OF NET WORTH CERTIFICATE

BSE Ltd., vide its notice no. 20110615-6, has allowed its members to include value of equity shares of BSE Ltd. for net worth computation after applying a 50% haircut to the fair value of the shares.

In the view of the same, CDSL has allowed the value of equity shares of BSE Limited (at 50% of the fair value of its shares as declared by BSE Limited for that year) to be included while computing the net worth of the DP. The effected change will be applicable for the net worth certificate of the year ended March 2011. The fair value of shares of BSE Limited duly certified by the Auditor of the Exchange is 169.90 per share and this value can be taken into account for the purpose of computation of net worth as on March 31, 2011.

BOs holding accounts with the DP are advised to take necessary steps to transfer their securities to another account with a DP of their choice.

STOCK CLINIC

"Stock Clinic" – a novel idea has proved to be very useful for promoting CDSL Demat at the retail level especially at branches of Bank DPs. In last few months, CDSL has conducted such programs at branches of Bank of India along with DPs, such as Asit C Mehta Investment Intermediates Ltd., GEPL Capital Pvt. Ltd. During the stock clinic, concepts related to demat and account opening are explained in a very simple language using a power point presentation. Customers can then ask queries and get their doubts resolved with the help of CDSL and DP staff. This program also helps staff of the DP to clear their queries regarding day-to-day activities being performed by them.
